- The name of the project : "Identification, Forecasting and Monitoring of Potential Fishing Zone for Tamil Nadu Coastal and offshore waters"
- Vacancy : One Research Associate (RA).
- Place of Posting : Fishery Survey of India (Head Quarters), Mumbai.
- Tenure : 2017-2019 and likely to be extended subject to the extension of project period.
- Status of the post : Purely on contractual basis at the Fishery Survey of India (HQs.), Mumbai.
- Essential qualification : M.F.Sc., / M.Sc., Zoology with specialization in Fisheries / Oceanography / Marine Biology with Ph. D., in relevant subjects followed by minimum 2 years of research experience in the respective fields.
