VACANCY NOTIFICATION

The Secretary to the Govt. of India, (Ministry of Fisheries, Animal Husbandry & Dairying, Deptt. of Fisheries), invites applications to fill up one post of Statistician (General Central Service, Group 'A' Gazetted, Non-Ministerial) in [Level-10(56100-177500) (PB-3 of Rs. 15600-39100/- + GP of Rs. 5400 - pre-revised)] in Fishery Survey of India, Mumbai a subordinate office under the administrative control of the Department of Fisheries, Ministry of Fisheries, Animal Husbandry & Dairying, by composite method [Deputation (including short term contract) plus promotion], from among the Officers working under the Central Governments or State Governments or Union Territories or Agricultural Universities or Autonomous or Statutory Organizations or Semi-Government or Recognized Research Institutions or Councils and possessing the following Qualifications/experience:-

1. a) (i) Holding analogous posts on regular basis or
OR
(ii) With 3/5 years regular service in posts in the scale of Rs.2000-3500/2000-3200/- [Pay Scale of Rs.6500-200-10500/- as per 5th CPC, Pay Band (PB-2) of Rs.9300-34800/- with Grade Pay of Rs.4200/- as per 6th CPC and Pay Matrix Level 6 of Rs.35400-112400/-as per 7th CPC(Pre-revised)] or equivalent and
- b) Possessing the following educational qualifications and experience, namely:
Essential:
 - i) Master's Degree in Statistics/Mathematics (With Statistics Operation/ Research or Economics/Commerce (with Statistics) from a recognized University or Equivalent
 - ii) Three years' experience in Collection, compilation analysis and interpretation of Statistical data.

Note 1: Qualifications are relaxable at the discretion of the UPSC in case of candidates otherwise well qualified.

Note 2: The qualification(s) regarding experience is/are relaxable at the discretion of the UPSC in the case of candidates belonging to Scheduled Castes or Scheduled Tribes, if at any stage of selection the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

Desirable:

- a) Degree or Diploma in Computer Science/Management from recognized University or Institute or equivalent.
- b) Familiarity with designing of Fishery Resources Survey Programme, Fish Stock Assessment suitable Statistical models for the same.

2. The Departmental Data Processing Assistant with 5 years regular service in the grade shall also be considered along with deputationists and in case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note 1:- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2:- Period of deputation including period of deputation in another Ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed 3 years. The maximum age limit for appointment by transfer on deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

The duties and Responsibilities of the post in brief are as follows:-

1. He will be in charge of the statistics cell at the Headquarters of the Institute.
 2. He will be primarily responsible for collection of data on Marine Fisheries Resources, cost of operation of vessels, performance statistics of vessels etc. by evolving suitable design for the same.
 3. He should ensure receipt and scrutiny of various information from the Bases as per the time-frame stipulated.
 4. He will be primarily responsible for the custody and upkeep of the data collected from the Bases.
 5. He should assist the System Analyst in evolving a suitable Management information System (MIS).
 6. He should assist the System Analyst for evolving a suitable storage and retrieval system for the management of the data.
 7. He will be responsible for the processing and statistical interpretation of the data required for the preparation of fishery charts and other publication of the organisation required for the feedback information of the Senior officers of the organisation in discharging their functions by monitoring the performance of the survey vessels of the Institute bases on the periodical reports received from the bases.
 8. He will be primarily responsible for the preparation of display charts, slides etc for exhibitions, meeting, workshop etc.
3. The pay of the official selected will be governed by the provisions laid down in the Department of Personnel & Training OM No.6/8/2009-Estt. (Pay-II) dated 17th June, 2010 as amended from time to time.

4.
